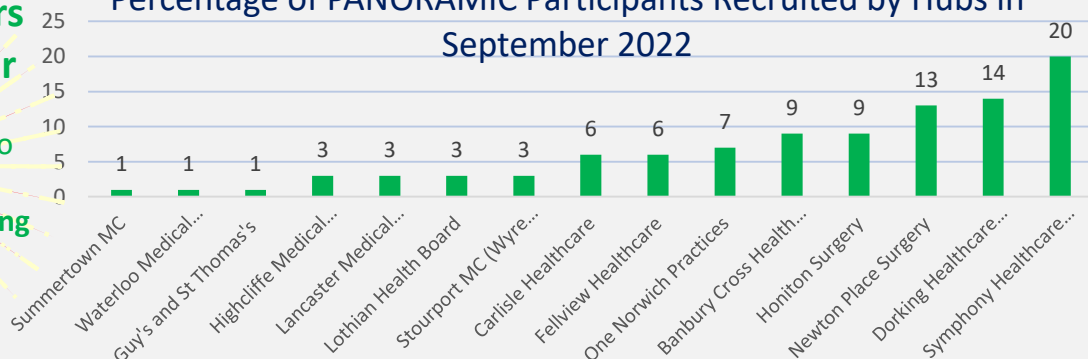
Virology Sub-study

Please invite potential participants to consider taking part in the **Virology Sub-study**, which is an aspect of the PANORAMIC trial. The Virology Sub-study, which reopened in September for the Paxlovid arm consists of a subset of participants from both the intervention and comparator arms of the PANORAMIC trial and seeks to determine the differences in viral load decay between those treated with or without antiviral medication.

Approximately 20% of patients referred to CMDUs for anti-viral treatment are ineligible for Paxlovid under CMDU criteria, but those patients may be eligible to take part in PANORAMIC. - All hubs on the Paxlovid arm now have access to a **free supply of LFD kits** to assist with recruiting potential participants. If you need help to order these, please get in touch.
- Further to recent **changes to the SAE section of the CRF**, please follow the **new working instructions** that have been disseminated to hubs.
- The team have been sending out **GP letters** to hubs for participant follow-up information. Both primary and long-term data are incredibly valuable to the trial, so please help us by completing and returning those letters.
- PANORAMIC has provided **SA06** to the Sponsor for review and approval. The proposed amendment includes measures to clarify procedures in respect of safety reporting, consenting and IMP returns.
