#### Virology Sub-study – Late delivery of Participant Pack

Participants randomised to the Paxlovid arm of the Virology Sub-study should receive both their **IMP and virology participant pack** on the day following randomisation. Please ask participants on the Paxlovid arm to await the delivery of the virology pack before taking their first dose to allow the recording of their baseline prior to the intervention. **However, please advise participants to take the first dose of the intervention if the virology pack has not arrived by 4pm.** To help prevent late deliveries, please complete all virology randomisations by **3pm**.

We will be emailing hubs a copy of our **PANORAMIC Recruitment Poster**. Please would you and your participating spokes display the poster to help us **promote awareness** of the trial among patients and staff.

#### Self-registration Checks

With self-registration now in operation please **regularly monitor** your hub's Spinnaker account for **newly self-registered** potential participants.

#### Completing AE Forms in Spinnaker

- If **more than one AE event** is reported, please complete them on **separate AE forms** in the database as **severity, causality and seriousness assessments** must be performed **for each separate event**.
- Any **updates** to a previously reported AE (e.g. event end date) should be **added to the existing form** - a new form **should not** be created.
- **Causality** has to be confirmed by **the Investigator**, via their database login, which has the necessary permissions.

#### Three and Six-month Follow-up Data

Over 3,000 no-contact follow-up letters have been prepared and posted to participants' GPs across the UK in the last few months. The information we receive back from these letters is **really important** for our long-term data analysis.
